

Our association is a local chapter of the National Association of Health Underwriters (NAHU). The role of OCAHU is to promote and encourage the association of professionals in the health insurance field for the purpose of educating, promoting effective legislation, sharing information and advocating fair business practices among our members, the industry and the general public.



Letter from OCAHU President, Maggie Stedt

Here's to *you*, OCAHU members! You are the hardworking service folks. You are the problem solvers, the champions of our clients, the experts in health insurance sales and renewals. Whether your focus is small-group, large-group, individual, ancillary products or senior products, you are *survivors*. We made it

through fourth quarter 2015! It has never been so challenging to be in the insurance business. Congratulations, OCAHU!

Your association has been there for you on the local, state, and national levels, making sure you have the most up-to-date information and support. Our current CAHU President Michael Lujan, for example, worked hard to continue improving agent support by Covered California. Here is a brief summary of the action taken on your behalf, directly from Lujan:

"What we did was collect and share feedback from dozens of agents who reported a different experience than was being reported. While the (Pinnacle) Agent Service Center wait times were slightly better than last year, most agents reported typical wait times of 40 to 90 minutes, not the 15 minutes being reported in Covered CA board meetings or memos. I personally called several times a day for more than two weeks and documented my own experience in detail. We had several calls and meetings with Covered CA to share the real experience and the issues needing urgent attention, misinformation and general refusal of the (Covered CA) Consumer Service Center to help agents even when the customer/applicant was also on the line. We also got Covered California to resume their Agent Webinar schedule (12/22) and will continue to work during the 'off-season' to prepare for next year's open enrollment. We are also expecting another year of supportive data showing the valuable role of the agent and the 40% share of total enrollment again this year (about 75% of the in-person enrollment) from agents. Clearly, consumers need agents and agents need the support and resources to do the job.

Thanks to the dozens of agents from all over the state who shared their personal stories and came to CAHU with private matters we were able to help get resolved. Sam Smith and Pat Burns did this long before I started as CAHU President. Our members need our help and we are glad we could help escalate and resolve their issues whenever possible. We continue to meet with Covered

California and Pinnacle bi-weekly and still have a long list of suggested improvements and issues to help resolve. Please continue to share feedback, specific examples and constructive ideas for improvement. Our work is far from finished but we appreciate your positive feedback from your chapters."

Let's extend a big thank you to Michael Lujan, our CAHU board, and our association members. This is your association at work!

As soon as you catch your breath, I encourage you to explore some of the opportunities and information coming your way. Make sure to take a look at the National Association of Health Underwriters' website NAHU.org. The site has webinars and training sessions available to help you expand your knowledge and explore new markets. Don't forget to participate in Operation Shout Outs, and get your Leading Producer Round Table applications completed and submitted!

We have a lot of great events planned for the remainder of the OCAHU year, and you do not want to miss them!

Make sure to join us on February 16th for our annual Business Development Summit at the Costa Mesa Hilton. This event will give you new perspectives on our industry, will help you earn CE credits, and will teach you ways to grow and protect your business.



- 4. **Carrier Management**: Carrier/home office sales managers, directors of sales and vice presidents of sales
