## Letter from OCAHU President, Patricia Stiffler

**A**s health insurance professionals, OCAHU members are facing an uncertain but exciting future. For this reason the theme of our Business Development Summit on February 19<sup>th</sup> was "Gaining the Edge." Our keynote speakers and breakout sessions were the perfect fit for a year when many of us will have to learn how to continue conducting our businesses and possibly even reinvent ourselves.

Over four hundred people attended the Business Development Summit which was the largest audience we had at this event in OCAHU's history. It was many of the attendees' first OCAHU event. Our vendors were kept busy greeting guest and promoting their products to many new faces.

Ron Goldstein from Choice Administrators started the day off with his presentation on Public and Private Exchanges. Ron had a lot of information to deliver and the audience would have been happy to spend several hours on the topic. Ron is a valuable source to many of us when on the subject of implementing exchange programs for our clients.

The breakout sessions were devoted to three tracks: Building Your Business, Innovation, and the Silver Tsunami. These sessions included both a medical panel and a professional panel, each moderated by Summit Chairman and President-Elect Rhett Bray. In the main room, Karli Dunkelberger presented a CE course on the History of Benefits and Health Reform Updates with an emphasis on compliance. In the afternoon Steve Tonelli showed the audience how important wellness components will be in future of health care. With over 10,000 people becoming Medicare eligible in the next 18 years the "Silver Tsunami" track has never been more relevant. Maggie Stedt and Matthew Hanson helped us understand how to transition the Medicare eligible from group to Medicare while Brian Berry from Easy Choice explained the new rules and regulations guiding the Medi-Medi plans. Because these sessions were all so relevant, the biggest complaint I heard was that it was hard to choose which breakout sessions to attend!

Sam Manfer from Sales Mastery gave a dynamic presentation on the topic of his book entitled "Take Me to Your Leader." With a combination of humor and common sense he showed us how to build our businesses by

strategically placing ourselves in the position to get to those at the top who make the decisions.

The best part of the day though was the presentation of the Pinnacle Award. This year's winner, Steve Course is one of the most deserving winners. For the past 18 years he has co chaired the One Heart at a Time Golf Tournament benefiting Cystic Fibrosis, a disease that both of his children have battled since early childhood. He has also been extremely successful in business as President of Best Life Health Plans. He is also Past President of OCAHU. His wife Emma and good friends, Past OCAHU Presidents, Jane Smith, Paula Wilson and Dorothy Coicu along with James Goodson of the Cystic Fibrosis Foundation and Susan Beeney from New Hope Grief Support were in attendance to applaud his achievement.

Our final Keynote Speaker, Olympic gymnast and Tony-winning actress Cathy Rigby delivered a heartfelt and uplifting talk. Her story was a true testament to the courage of overcoming personal demons and reinventing yourself. It was a great way to end a dynamic Summit.



## The “Real Issues”

**A**s I write this article I am preparing for my third trip to Washington, D.C. for **NAHU’s 23<sup>rd</sup> Annual Capitol Conference**. Last year was my first year attending and I am even more excited to have the privilege of attending again this year, representing the members of OCAHU. The small group of OCAHU members attending this year’s conference will be meeting with representatives from the offices of Congressman John Campbell, Congressman Ken Calvert, Congressman Darrell Issa and Congressman Dana Rohrabacher. We will be discussing with them the “**Real Issues**” that we believe need to be reformed within the health care system such as:

**The Cost of Medical Care** – Affordability is the key to the success of health reform. Creating new health coverage access will be a wasted effort if people are unable to pay for their coverage and/or care

**The Ever-Increasing Cost of Health Insurance** – Health insurance is expensive because the cost of medical care is expensive. The new taxes and fees coupled with new mandated benefit requirements and changes to the way health coverage is going to be priced are only adding to the cost of health insurance


**The Burden on Businesses** – High health care costs and new coverage requirements are hindering our nation’s economic growth. When these cost drivers are combined with myriad new compliance responsibilities that employers must now perform on behalf of their employees, it is no surprise that many companies are reevaluating their benefit choices

**Ensuring Access to Licensed Benefit Professionals** – Health insurance consumers need assistance, trustworthy advice and service from folks who truly know the health insurance world. We need policymakers to ensure that health insurance consumers will always have the ability and option to work with licensed professionals, such as ourselves; and we need to be paid for our work

**Taking Care of the Future** – Policymakers should make every effort to ensure that the safety nets that provide health coverage to lower-income and older Americans are solvent, stable and efficient. Not only do millions of Americans depend on both the Medicare and Medicaid (Medi-Cal for us) programs, but the performance and stability of these programs also impact healthcare costs for all other privately insured individuals in this country.

As a member of OCAHU/CAHU/NAHU, part of our job is to be working with our local, state and federal representatives to make good legislation that pertains to health care, and to correct legislation that is in the works or already passed wherever we can so that it benefits the health care consumer. We are the health insurance consumers' advocates, trusted advisors and service partners. How can we be advocates for and trusted advisors to our customers if we have answers or ideas on how to correct the health care system, without ever voicing our thoughts to our government officials? Those officials have the ability to make real changes, and it's important we speak with them! I invite every OCAHU member to join in. If you couldn't attend the Capitol Conference, start thinking now about attending **CAHU's Day at the Capitol** in Sacramento which is May 14<sup>th</sup> and 15<sup>th</sup>. And even before that, start talking with your local Congressman or Congresswoman in your home and work districts. We all need to do our parts to help turn healthcare legislation into something that tackles problems with our current healthcare system.

To find your local and state legislators go to [www.legislature.ca.gov](http://www.legislature.ca.gov). Meet with your representative and go over the issues that are important to NAHU, CAHU and to you as a health insurance broker. Give examples of how self-insured clients are benefitting from the use of such insurance vehicles. Talk about wellness and how it helps bring down the cost of health care. Let them know that the new 3:1 ratio for age rating will significantly increase the cost of insurance for the "young invisibles," the population essential in keeping cost of health insurance down. Give your Congress representative insight into what you do and why your role in the health care system is important.

**W**hat special designations can you achieve in our industry? Have you looked into all the designation opportunities available through our organization? LPRT, RHU, REBC, DIA, CLTC, CSA and more might be just for you! For more information about the designations below please visit [www.nahu.org](http://www.nahu.org).

A **Leading Producers Round Table (LPRT)** designation *encourages excellence among NAHU's health and benefit insurance professionals by recognizing their sales achievements. Also, LPRT members receive discounts on many NAHU services and meetings as well as invitations to exclusive LPRT events. The qualification categories are Personal Production, Carrier Representatives, Agency, and Carrier Management.*

The **Registered Health Underwriter (RHU)** designation is the undisputed professional credential for persons involved in the sale and service of disability income and health insurance. Individuals earning the RHU designation demonstrate a high level of knowledge about the principles and practices governing the disability income and health insurance business.

The **Registered Employee Benefits Consultant (REBC)** program focuses on providing the student with the knowledge necessary to become a professional in the sale and service of employee benefits plans.
